As a mother of four children, Laura is one of many North Texas parents who's grateful for your generosity. This past summer, she and her kids — ages 6 to 10 — became homeless shortly after moving in with Laura's mother.

After living with a serious knee injury that's made it difficult for her to find steady employment, Laura decided staying with family would help her save up enough money for another surgery —

hopefully her last. At the time, temporarily sharing a roof with the kids' grandma seemed like a good idea.

Laura learned soon after moving in that her mother was having financial troubles. When Laura came across an eviction notice in the house one day, she was devastated. What would happen to her family?

When the day of their eviction arrived, Laura and the kids had

nowhere to go. She recalls the restless night they spent huddled together in a nearby park, their belongings hidden under nearby bushes.

Finding out about the Arlington Life Shelter was the ray of light she desperately needed. Because of your support, her kids are safe and sleeping in warm beds and receiving food and activities to

help them grow. Laura's been busy searching for a job that won't put too much strain on her knee while she waits for her next surgery to be scheduled.

The peace of mind you've brought to Laura — and many other families with young children — means so much. Being homeless is extremely stressful, especially when you have kids. Laura can't thank you enough for what you've done for her through your gifts.

"Carol loved to help people in their time of need," says Steve Zimmer of his late wife.

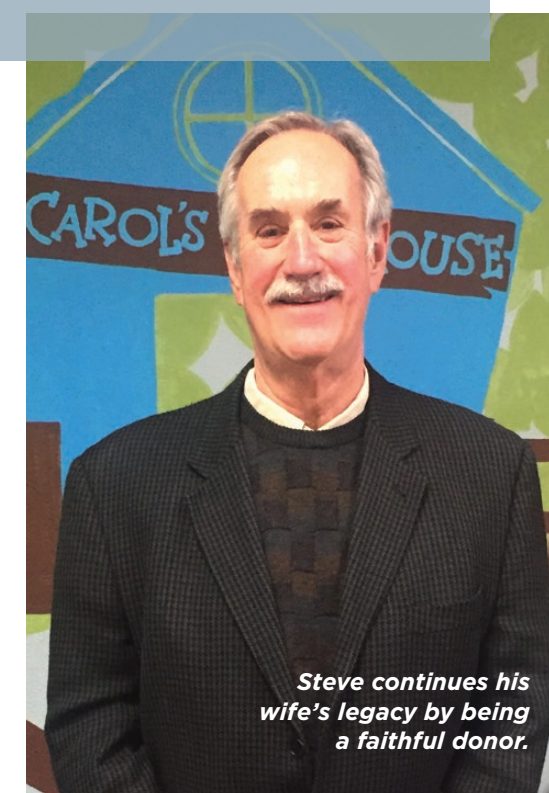
Before she passed away in 2013 after a 12-year battle with Lou Gehrig's disease, Carol Zimmer dedicated much of her free time to serving our homeless neighbors in North Texas. For the most part, Carol focused her efforts on making the [Arlington Life Shelter](#) a safe place for children to learn and grow.

While Carol volunteered, Steve worked as an accountant with Accenture. After 30 years with the company, he was able to retire early, which allowed him to spend quality time with Carol as she reached the end of her life. Today, he's still grateful he was able to be with his wife and their children when it mattered most.

Steve and Carol joined Road Home, the agency's first sustainable giving program, several years ago. As a way to continue Carol's legacy, Steve made a pledge to support the Shelter with an additional annual gift. The funds are earmarked to help meet the Shelter residents' most urgent needs.

Because he truly believes in the mission at the Arlington Life Shelter — just as Carol did — he's not shy about encouraging his neighbors to pitch in as well in his effort to end homelessness in this community. He gives a few very convincing reasons why others should get involved.

"You are providing a needed service to your community," says Steve. "This isn't just a landing place — it gets our neighbors to improve themselves."

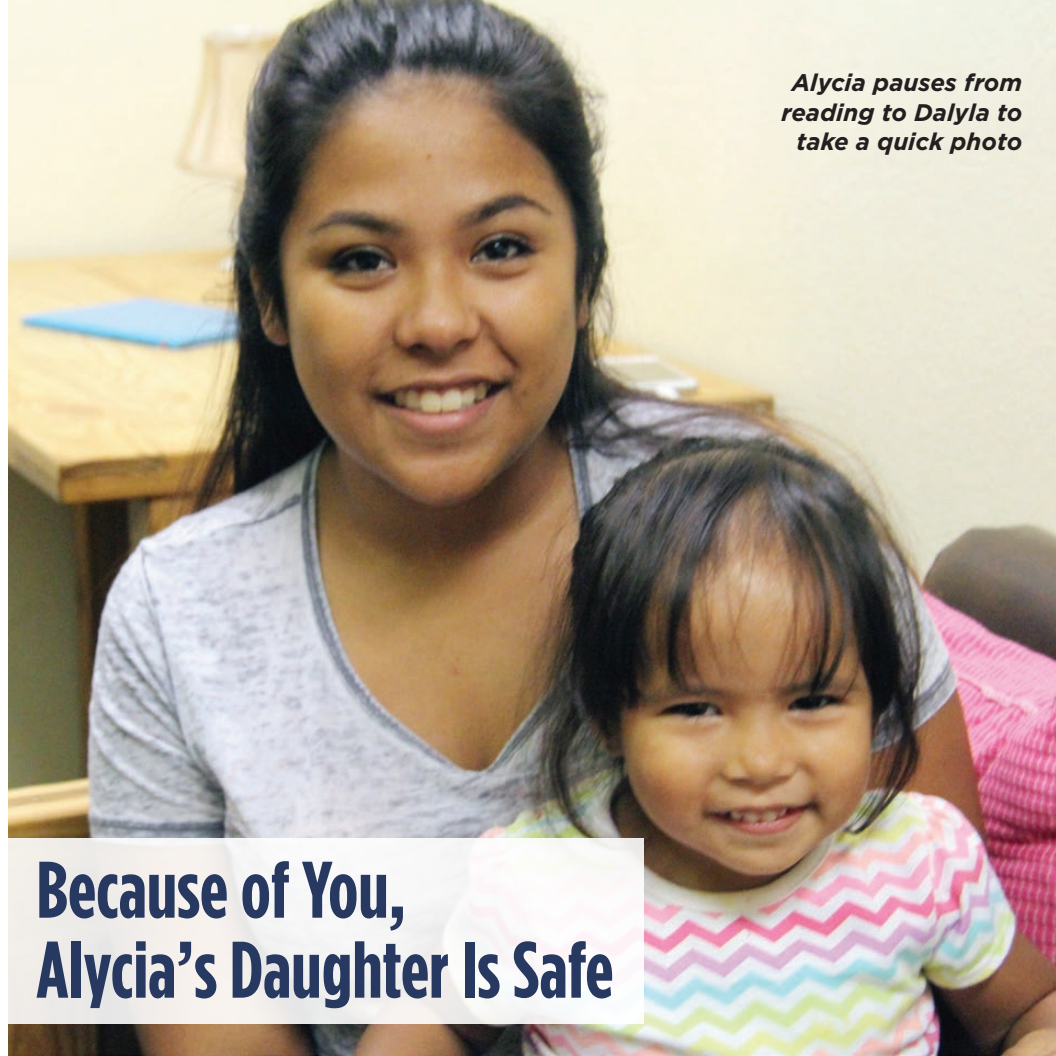
