

A Fresh Start for Victor



Victor looks forward to a new job and a stronger future

Two years ago, Victor moved to Arlington to be closer to family, hoping to work with his half-brother while also recovering from multiple surgeries.

But then his half-brother ended up moving to Alaska — and despite submitting dozens of job applications, Victor couldn't find another

job in time and went through all his savings. He could see homelessness on the horizon.

When Victor found out about the Arlington Life Shelter, he came right away.

"It means quite a lot that this resource is even here," he says. As a single man, he wasn't sure what services were available to help him. He was glad to find a safe place to land, where caring staff helped him apply for SNAP benefits and health insurance. "Everyone that works here is very willing to help you."

Within a few months, Victor found a new job in manufacturing. "It's good pay, good hours," he says. "Hopefully it will stabilize me enough to actually breathe a little bit."

Now, Victor is ready to start saving and moving towards his dream career in back-end coding. Years of playing video games evolved into a passion for coding. "I'm planning to...learn a few coding languages, get a few certificates," he shares.

In the near future, Victor is excited to have his own space again and return to self-sufficiency. Thank you for helping Victor reach a new day, home and life!

Talk to our neighbor Charlene, and you’ll notice right away her caring heart and warm personality. “I’m a people person,” she explains.

Two years ago, Charlene made the difficult decision to leave her family’s home in Arkansas because it was no longer safe for her sons, now ages 22, 20, and 16. After moving to Arlington, the family stayed in a hotel with support from Charlene’s mom while she searched for housing and work.

But weeks turned to months, and after a year, there wasn’t enough support to stay. Charlene started looking for other options. She landed at the Arlington Life Shelter with her youngest, while her oldest son found a job and moved into an apartment he shares with Charlene’s middle son.

Right away, Charlene began taking steps to secure a new job, updating her resume and spending hours applying in our computer lab. That added resource and support made all the difference.

“The first week I was here, I got myself a job,” she shares.

Charlene also attended our parenting class, and her case manager helped her fill out housing paperwork. Now, she’s closer than ever to stability, and looking forward to resuming classes to become a traveling nurse. “It’s something I’ve always wanted to do,” she says.

IRA QUALIFIED CHARITABLE GIVING

DONOR-ADVISED FUND (DAF)

Often an alternative to establishing a private foundation, a donor-advised fund allows you to maximize your donations with less expense and paperwork. Donor-advised funds are managed by institutions or foundations, so you can avoid additional expenses associated with starting and maintaining a foundation, all while collaborating to make sure your funds are going exactly where you want them.
